Monthly Insurance Licensing Advisory Committee (“ILAC”) Application Review

There were fifteen insurance applications reviewed in December; thirteen of the applications were approved and two were withdrawn.

Registration/Licensing of approved insurance entities is subsequent to the ILAC application process and may be confirmed in future periods.
