Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

In May 2026, five insurance applications were reviewed by the IALC, comprising of all new applications. Of the five applications, four were approved and one was deferred.

The registration of approved insurance entities occurs after the IALC application process has concluded. Therefore, the IALC approval and the registration approval may be rendered in different periods.
